



INVITATION TO BID FOR *SUPPLY AND DELIVERY OF BRAND-NEW MOTOR VEHICLE*

1. The *National Academy of Science and Technology*, through the *General Appropriations Act of 2024* intends to apply the sum of *One Million Four Hundred Thousand Pesos Only (P1,400,000.00)* being the ABC to payments under the contract for *Contract No. 2024-26*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *National Academy of Science and Technology* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Thirty (30) days from receipt of the Notice to Proceed*. Bidders should have completed, within *one (1) year* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *National Academy of Science and Technology* and inspect the Bidding Documents at the address given below during *8:00 a.m. to 5:00 p.m.*, Monday to Friday
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 26, 2024 to July 16, 2024** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *National Academy of Science and Technology* will hold a Pre-Bid Conference¹ on *July 4, 2024; 10:00 am at the NAST Conference Hall*, which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **July 16, 2024; 10:00 am**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **July 16, 2024; 10:30 am at the NAST Conference Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **National Academy of Science and Technology** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
